

Call for Nominations for CHA Prizes and Awards

THE ALBERT B. COREY PRIZE

The Albert B. Corey Prize in Canadian-American Relations, jointly sponsored by the Canadian Historical Association and the American Historical Association, will be awarded in June 1992 at the Annual Meeting of the Canadian Historical Association. The prize, which carries an award of \$2,000 (Canadian), will be awarded to the best book dealing with the history of Canadian-American relations or the history of both countries.
