

he established a research service for trade unions at a time when such services didn't exist for unions, even in Québec's labour federations. He had felt that there was a pressing need for union demands to be based on a solid analysis of social and economic data. As a result, a very large number of unions affiliated with the CNTU or the QFL hired him as a consultant. Through his teaching of industrial relations, an entire generation of students benefited from his knowledge of unions. His influence was also felt through the news media, where his capacity to communicate and to make even the most complicated situations understandable was greatly appreciated.

He did not lose contact with workers when he became a university professor in 1965. He gave seminars to union members, was governor of the Labour College of Canada (1973-80) and served on the Board of Directors of the Institut de recherches appliquées sur le travail (1977-85). A generous and gracious man, he was equally at home when surrounded by academics or workers. His loss leaves a large gap among his fellow historians of the labour movement. He was one of those rare academics who was able to combine his work as a historian with a practical experience of trade unionism.

En devenant professeur de relations industrielles, il a mis par la suite à profit pour toute une génération d'étudiants et d'étudiantes ses connaissances du milieu syndical. Son rayonnement s'est fait sentir aussi par l'intermédiaire des médias d'information où on appréciait ses talents de communicateur et sa facilité pour vulgariser les situations les plus complexes.

Devenu universitaire en 1965, il n'a pas perdu contact avec les travailleurs; il donnait des séminaires aux syndiqués, il était gouverneur du Collège canadien des travailleurs (1973-80) et membre du bureau de direction de l'Institut de recherches appliquées sur le travail (1977-85). Homme affable et généreux, il était aussi à l'aise en milieu académique que parmi les travailleurs. Sa perte laisse un vide important parmi la communauté des historiens des travailleurs; il était un des rares chercheurs à pouvoir combiner son travail d'historien à une expérience pratique du syndicalisme.
